I. Catalog Description

Exploration of Musical Instrument Digital Interface (MIDI) systems and applications. Includes the MIDI language and applications in the studio environment using software-based sequencing programs. (2:2).

II. Course Objectives

Upon satisfactory completion of this course, the student will be able to:

- A. Describe the basics of MIDI technology.
- B. Explain how MIDI and audio digital information is used in digi-recordings.
- C. Utilize sequencer for manipulation of MIDI data.
 - 1. Utilize multiple tracks.
 - 2. Orchestration by using different sounds, loops, and voices.
 - 3. System real time and rendered messages.
 - 4. MIDI implementation by editing velocity, quantization, and positioning.
- D. Understand the elements of digital track recording including:
 - 1. Input audio signal.
 - 2. Input MIDI information.
 - 3. Record MIDI information.
 - 4. Record audio information.
 - 5. Edit MIDI information.
 - 6. Edit audio information.
 - 7. Mix and process audio.
 - 8. Finalize audio tracks.

III. Learning Outcomes (WECM)

- 1. Summarize the MIDI protocol.
- 2. Set up MIDI controller-virtual instrument and/or external hardware instrument.
- 3. Utilize software-based sequencing programs.

IV. Evaluation

- A. Tests will be given to determine the student's progress and understanding of the course material; a minimum of 3 quizzes (exams) and a final exam will be administered.
- B. Reading assignments and home projects will be given to aid the student in understanding the course material
- C. Students will be required to submit 3 projects during the course for instructor evaluation
- D. Attendance requirements will be specified by the instructor and may be factored into the student's final grade.
- E. To determine the student's final grade, the instructor will average exam scores, projects, and completed assignments; Grades will be based on the following scale:

90-100 = A
80-89 = B
70-79 = C
60-69 = D
Below 60 = F
