I. Catalog Description

Advanced harmony voice leading, score analysis and writing of more advanced tonal harmony including chromaticism and extended-tertian structures. Optional correlated study at the keyboard. Open to all.

Prerequisite: MUSI 1312 with a “C” or better, or with permission from the Music Program Coordinator. Corequisite: MUSI 2116. (3:0).

II. Course Objectives

Upon satisfactory completion of this course the student will be able to:

- A. Identify and write any given major, minor chromatic scale
- B. Classify intervals by type, and as consonant or dissonant, and write any given interval.
- C. Write the circle of fifths, and use it in identifying successive key signatures.
- D. Classify triads as major, minor or diminished: indicate by Roman numerals and by key signatures their possible variations: and write any given triad.
- E. Describe triad inversions, and write any given triad inversion.
- F. Describe “doubling” as it pertains to the triad.
- G. Write music using close position and open position.
- H. Write and apply two rules of thumb pertaining to the connection of chords.
- I. Identify the direct octave and the direct fifth.
- J. Identify “overlapping” and “crossing” in musical examples.
- K. Write a four-part harmony to a given base line, using root position.
- L. Identify and write possible triads in the minor mode.
- M. Describe the relationship of relative major and minor keys.
- N. Write a four part harmony exercise using triads in first inversion when indicated.
- O. Write out a given four-part harmony indicated by a given figured bass.

III. THECB Learning Outcomes (ACGM)

Upon successful completion of this course, students will:

1. Construct and identify extended-tertian and chromatic harmonies.
2. Analyze musical compositions, which include various forms of tonal modulation utilizing standard roman-numeral symbols.
3. Demonstrate proper voice-leading practices through composition in appropriate styles.
4. Demonstrate concepts covered in class on the keyboard, including progressions that utilize

- modulation.
5. Demonstrate an understanding of rhythmic meter and note duration through score analysis and composition.

IV. Evaluation

- A. Examinations, quizzes, and homework assignments, as well as a comprehensive final examination will be given throughout the semester.
- B. Scores on the tests and the final exam will be averaged to find the percent score for the course. Percent scores will be converted to letter grades according to the following scale:

90 to 100 = A
80 to 90 = B
70 to 80 = C
60 to 70 = D
below 60 = F
