I. Catalog Description

A health-related work-based learning experience that enables the student to apply specialized occupational theory, skills, and concepts. Direct supervision is provided by the clinical professional. Provides an opportunity to utilize the roles of the vocational nurse while providing nursing care for adult clients. Students must pass VNSG 1260 and VNSG 1402, VNSG 1160 and VNSG 1323 with a grade of "C" or better to enroll in this course. A grade of "C" or better is required in this course to take the next course. **Corequisites: VNSG 1166 and VNSG 2214. (0:4). Professional Practice Insurance required.**

II. Course Objectives

Upon satisfactory completion of these units, the student will be able to:

- A. Unit I. Nurse as a Provider of Patient-Centered Care
 - 1. Demonstrate the ability to use the nursing process with emphasis on reassessment based on evaluation while caring for medical-surgical patients. (SLO #2)
 - Apply critical thinking skills at an intermediate student vocational nurse level that relate to the evaluation of goal achievement and reassessment for medical-surgical patients. (SLO #4, 5)
 - 3. Assist in determining the health status and health needs of adult medical-surgical patients based upon interpretation of health-related data and preventive health practices in collaboration with patients, their families, and other members of the immediate health care team at the advanced medical-surgical level of an intermediate VN student. (SLO #3, 4, 5)
 - 4. Assist in the formulation of goals/outcomes and a plan of care for adult medical/surgical patients in collaboration with patients, their families, and interdisciplinary health care team members at the advanced medical-surgical level of an intermediate VN student. (SLO #1, 2, 5, 6)
 - 5. Implement plan of care within legal and ethical parameters, including scope of education, for adult medical-surgical patients in collaboration with patients and interdisciplinary health care team members to assist patients in meeting health care needs at the advanced medical-surgical level of the intermediate VN student. (SLO #3, 4, 5)

- 6. Implement teaching plan for adult medical-surgical patients with common health problems and well defined learning needs at the advanced medical-surgical level of an intermediate VN student. (SLO #2)
- 7. Assist in the evaluation of medical-surgical patients' responses and outcomes to therapeutic interventions at the advanced medical-surgical level of the intermediate VN student. (SLO #4, 5)
- Provide direct basic care to multiple assigned adult medical-surgical patients in structured settings at the advanced medical-surgical level of an intermediate VN student. (SLO #4)
- 9. Use the problem-solving approach as the basis for decision making in nursing practice at the advanced medical-surgical level of an intermediate VN student. (SLO #4, 5, 6)
- B. Unit II. Nurse as a Member of the Health Care Team
 - 1. Assist in the coordination of human and material resources for the provision of care for assigned adult medical-surgical patients at the advanced medical-surgical level of an intermediate VN student. (SLO #1, 5, 6)
 - 2. Collaborate with adult medical-surgical patients and the interdisciplinary health care team to provide direct care to assigned individual patients at the advanced medical-surgical level of an intermediate VN student. (SLO #6)
 - 3. Participate in the identification of adult medical-surgical patients' needs for referral that facilitate continuity of care at the advanced medical-surgical level of the intermediate VN student. (SLO # 1, 3)
 - 4. Participate in activities which support the organizational framework of structured health care settings as an intermediate VN student. (SLO #1, 5)

IV. THECB Learning Outcomes (WECM)

As outlined in the learning plan, apply the theory, concepts, and skills involving specialized materials, tools, equipment, procedures, regulations, laws, and interactions within and among political, economic, environmental, social, and legal systems associated with the occupation and the business/industry and will demonstrate legal and ethical behavior, safety practices, interpersonal and teamwork skills, and appropriate written and verbal communication skills using the terminology of the occupation and the business/industry.

V. Evaluation

Proficiency Exams: Any student wishing to challenge a nursing course should speak to the Nursing Challenge Advisor and/or to the Nursing Counselor. All nursing courses in the vocational nurse program can be challenged if available, but the student must meet residency requirements and have 6 vocational nursing hours at El Paso Community College to be a graduate of the EPCC Vocational Nurse Program.

Articulation: Articulation plans for the vocational nursing program are available and will be addressed by the nursing counselor.

A. Pre-clinical drug calculation Assessment

Mastery of drug calculations must be demonstrated for all nursing clinical courses. A score of 90% or higher on a pre-clinical drug calculation assessment examination must be received. Students must receive the 90% score prior to administering medications in the clinical setting. This applies to all students taking or auditing a theory or a clinical course to include the first semester. This will validate their knowledge and skills as they prepare to advance to the next course and provide an opportunity for remediation, if appropriate. The first attempt at the calculation examination/math test will be counted as a theory quiz. A 10-point deduction from the A.D.N./VN Competencies (clinical evaluation) for each day that medications cannot be administered plus other areas as applicable. The Math exam will be offered once weekly.

B. Vocational Nurse Clinical Competencies

There will be 2 clinical evaluations during the course one at midterm and the other at the end of the rotation. The two evaluations are averaged together and count for 65% of the clinical grade.

C. Nursing Care Plans

One (1) Nursing Care plan (NCP) utilizing the EPCC Nursing Care plan format is required. Date for submission will be announced.

The care plan emphasis at the VN level is assessment, planning, implementation and evaluation. The NCP diagnosis is done in collaboration with an RN. For course purposes, the student will be required to include nursing diagnosis on the NCP.

The graded care plan must have 5 diagnoses and goals, but only 3 must be carried through completely.

The care plan is to be for **current** care delivery on a chosen client. NCP development should begin on the first day of a clinical rotation. It should be utilized to care for the client. (See Appendix)

D. Teaching Plan

One teaching plan will be required for this course. Date for submission will be announced by each individual instructor. The teaching plan/presentation is graded. Failure to do a teaching plan for the rotation will result in a zero for the teaching plan. These must be done for course completion. (See Appendix)

E. Mastery of Previously Learned Concepts

Several threads of the curriculum are being tested on exams in VNSG 1314, a corequisite to course VNSG 1163. The student should be able to respond appropriately to the instructor(s) about any and all content areas previously learned as it relates to the medical-surgical clients or to what is currently being taught in VNSG 1314. The content areas and curriculum threads include, but are not limited to, the following: math, history and physical examination, nursing process, nutrition, therapeutic communication, client teaching, pharmacology, and medical-surgical nursing (as appropriate).

F. Remediation

Students who do not demonstrate competency in the VN competencies, nursing care plans and client teaching plans will receive a counseling form with recommendations for improvement. Failure to meet the stated recommendations will place the student in jeopardy of failing the course.

If the student fails the course, the student will receive a counseling form and/or student data exit form with recommendations for improvement so that the student can be successful. The student will need to apply to the readmission committee for the nursing department. *See Nursing Student Handbook.

G. Grading Criteria

The student must obtain a minimum grade of 78% in this course for successful completion. In addition, the average of the two clinical competency grades must yield a minimum score of "75." Anything less than 78% on the averaged competencies will result in failure of the course.

The following grading scale will be utilized:

1. Scores on each examination, assignment or clinical evaluation will be rounded and recorded to the closest whole number.

2. Final Course grades will NOT be rounded to the closest whole number. A 78.00% is needed to pass the course with no rounding (i.e. 74.7 would be recorded as 74 and not rounded up to 75; 89.9 stays 89 and would not be rounded up to 90).

- 3. Rounding rule: All grades except for Final Course Grade
 - a. To determine scores to record, use the value in the tenths column only do not carry out any further. (82.459 would be recorded as 82 because only the tenths column is looked at).
 - b. 0.5 and above will be rounded to the next higher whole number (i.e., 84.6 becomes 85).
 - c. 0.4 and below will be rounded by dropping the tenths and leaving the whole number (i.e., 84.3 becomes 84).
