



LVN-RN TRANSITION APPLICANTS- ATI PN COMPREHENSIVE PREDICTOR INFORMATION SHEET

The ATI PN Comprehensive Predictor assessment is required for qualification and ranking into the LVN-RN Transition program **ONLY**.

1. What is the cost of the PN Comprehensive Predictor assessment, and where can I take it?

ATI PN COMPREHENSIVE PREDICTOR EXAM

The ATI PN Comprehensive Predictor schedule is found on the EPCC Testing Center website along with the following information.

- Visit any EPCC Testing Center and pay the \$10 administration fee to schedule a testing appointment.
 - Students who do not show up or cancel their test prior to the scheduled time will forfeit the \$10 administration fee and will have to repay.
- At the Testing Center, students will log in to [atitesting.com](#) with their username and password. They will be required to pay the \$50 plus tax, non-refundable testing fee. The testing fee is payable with a credit/debit card.

- Once a student has tested, scores will be available in Banner **24 to 48 hours** after completion of the test. Students can view and print an unofficial copy of their results anytime at [www.atitesting.com](#).

2. How often can a student retest?

- A student can test or retest up to (2) **two times**. **After a second unsuccessful attempt to meet the minimum passing score, the student must wait 6 months** prior to re-testing (No exceptions).

3. When does a 6-month period start counting toward ATI PN Comprehensive Predictor testing and retesting?

- A six (6)-month period starts at the **last** time a student tests.

4. What happens when a student has exhausted their two attempts without successfully meeting the minimum 90% passing score?

- A student who has unsuccessfully attempted ATI PN Comprehensive Predictor two times, either at EPCC or at another institution, will need to **wait six months** before retesting (**No exceptions**).

5. Do weekends and holidays count toward the 21-day waiting period?

- Weekends and holidays **do count** toward the 21-day waiting period.

6. What happens if I re-test prior to the 21-day waiting period?

The EPCCCD does not discriminate on the basis of race, color, national origin, religion, sex, age, disability or veteran status.

- ATI will allow you to register for the exam, and the EPCC Testing Center will administer the test. However, your test results will be **invalid** for EPCC qualification and ranking. Test scores **will not be posted** on our Banner system, and **No Refund** will be provided by ATI.
- 7. What are the minimum passing scores for the LVN-RN Transition program at El Paso Community College?**
- A **minimum score of 90%** is required for qualification and ranking.
- 8. How old can test scores be?**
- *ATI PN Comprehensive Predictor* scores are **valid for two years**, and **only the most recent scores** will be used for qualification and ranking. Official scores from testing required for completion of a VN program can be used to rank (if current).
- 9. Study materials**
- Study apps can be found on the internet.
 - A study guide can be purchased on the internet through various vendors.
 - Preparation tools are found on the internet.
- 10. What are the weighted percentages for ranking with the ATI PN Comprehensive Predictor?**
- The ATI PN Comprehensive Predictor **is only a qualifying factor for ranking into the LVN-RN Transition program**, and a higher score does not impact your ranking score for the program.
- 11. Will we accept ATI PN Comprehensive Predictor scores taken at other institutions?**
- *ATI PN Comprehensive Predictor* transcript must be officially sent from ATI. Check with ATI to determine the fee assessed to send the transcript. Unofficial scores cannot be **accepted** for qualification.
- 12. Can we accept unofficial ATI PN Comprehensive Predictor scores?**
- Unofficial *ATI PN Comprehensive Predictor* scores can be used for **advising purposes only**.
