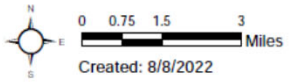
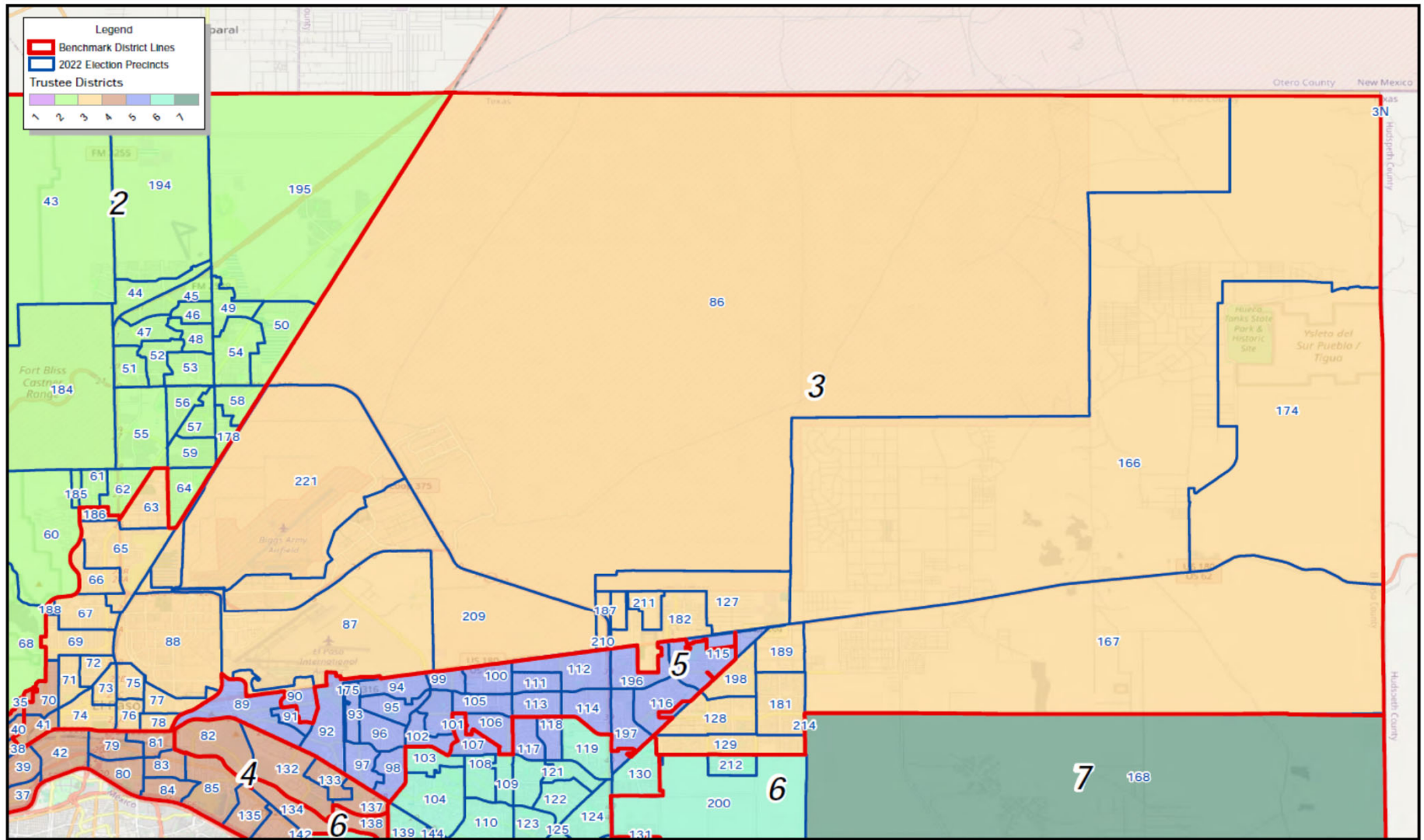

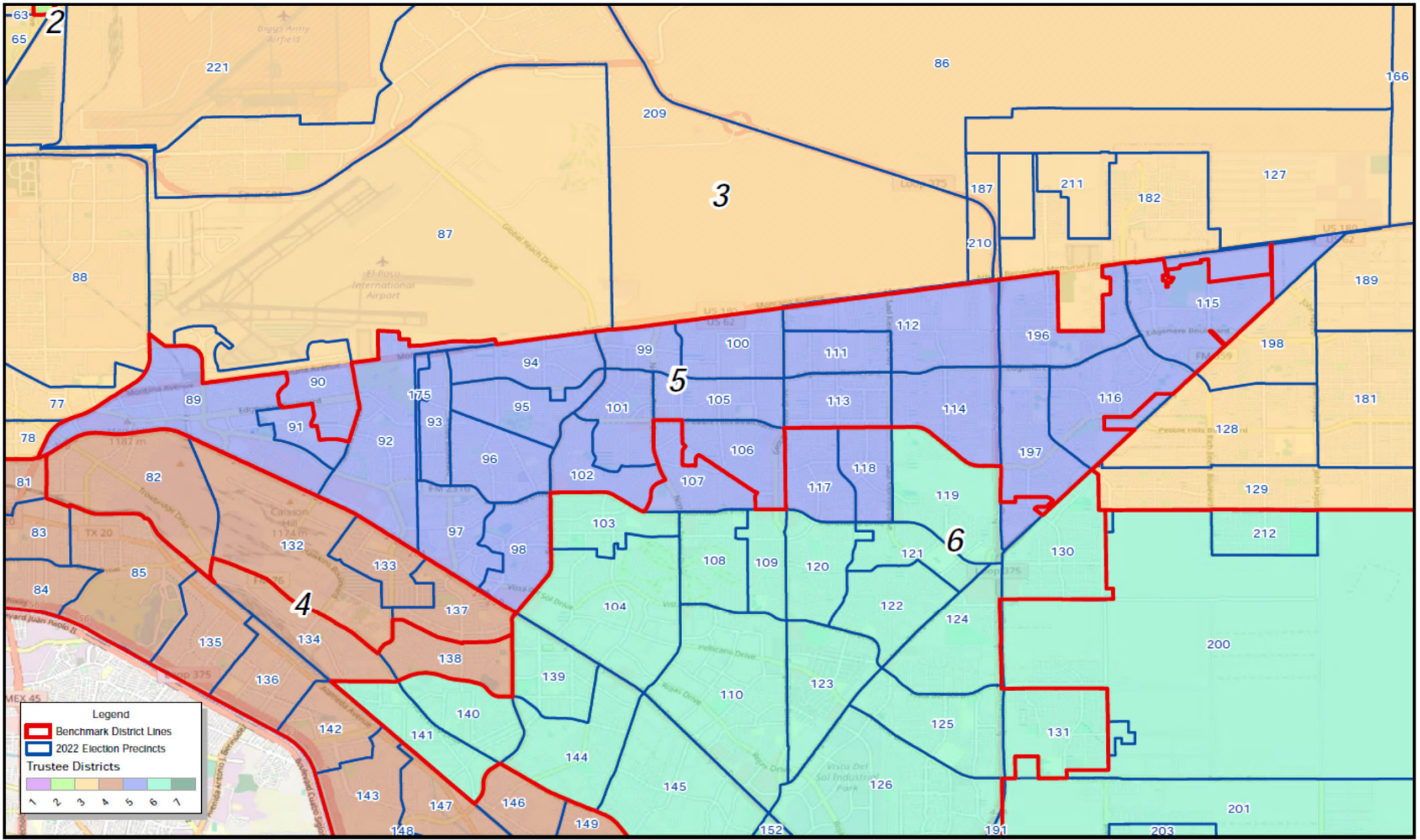




El Paso Community College Trustee District 3 - Illustrative Plan 1

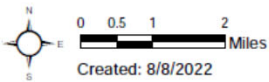
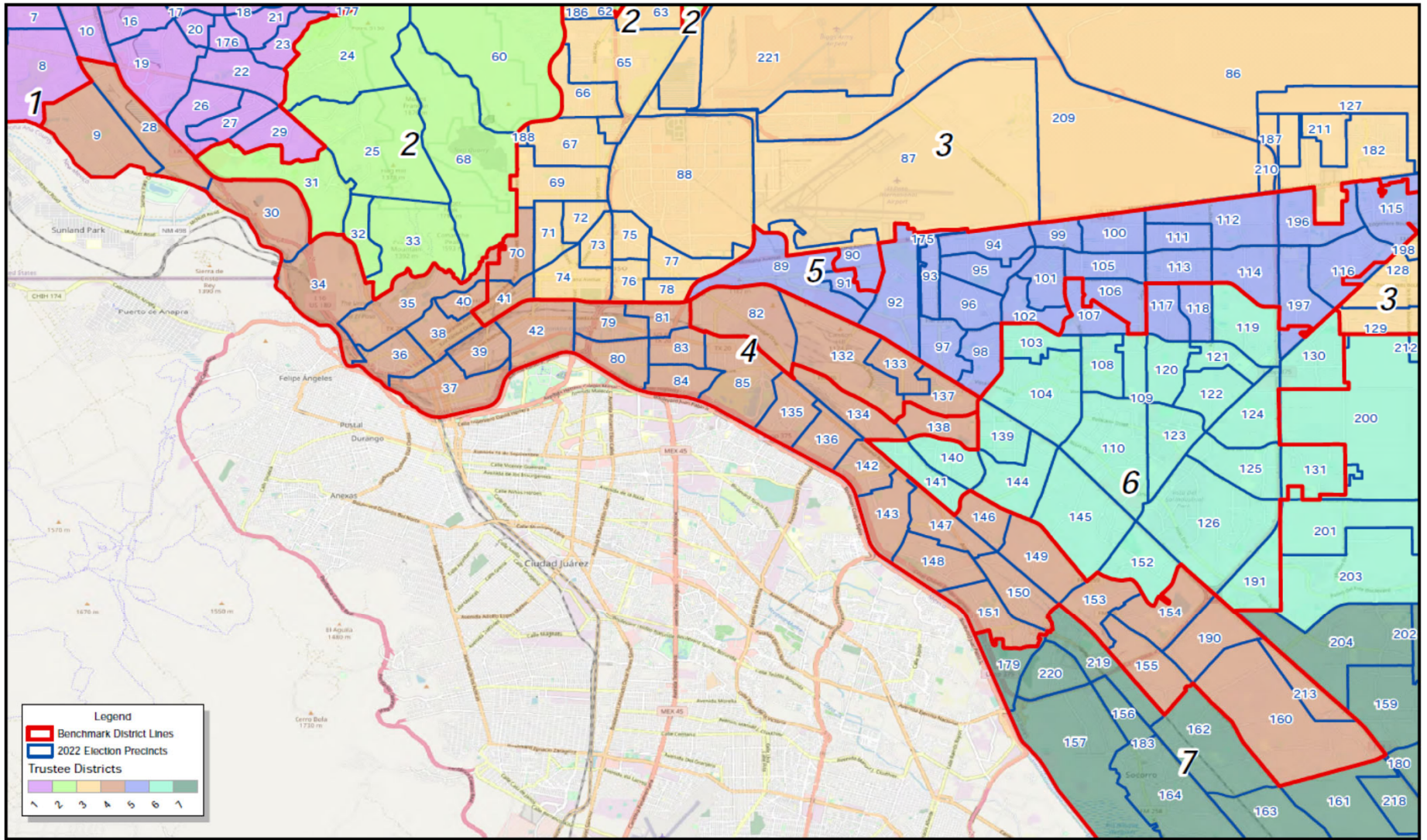


El Paso Community College Trustee District 5 - Illustrative Plan 1

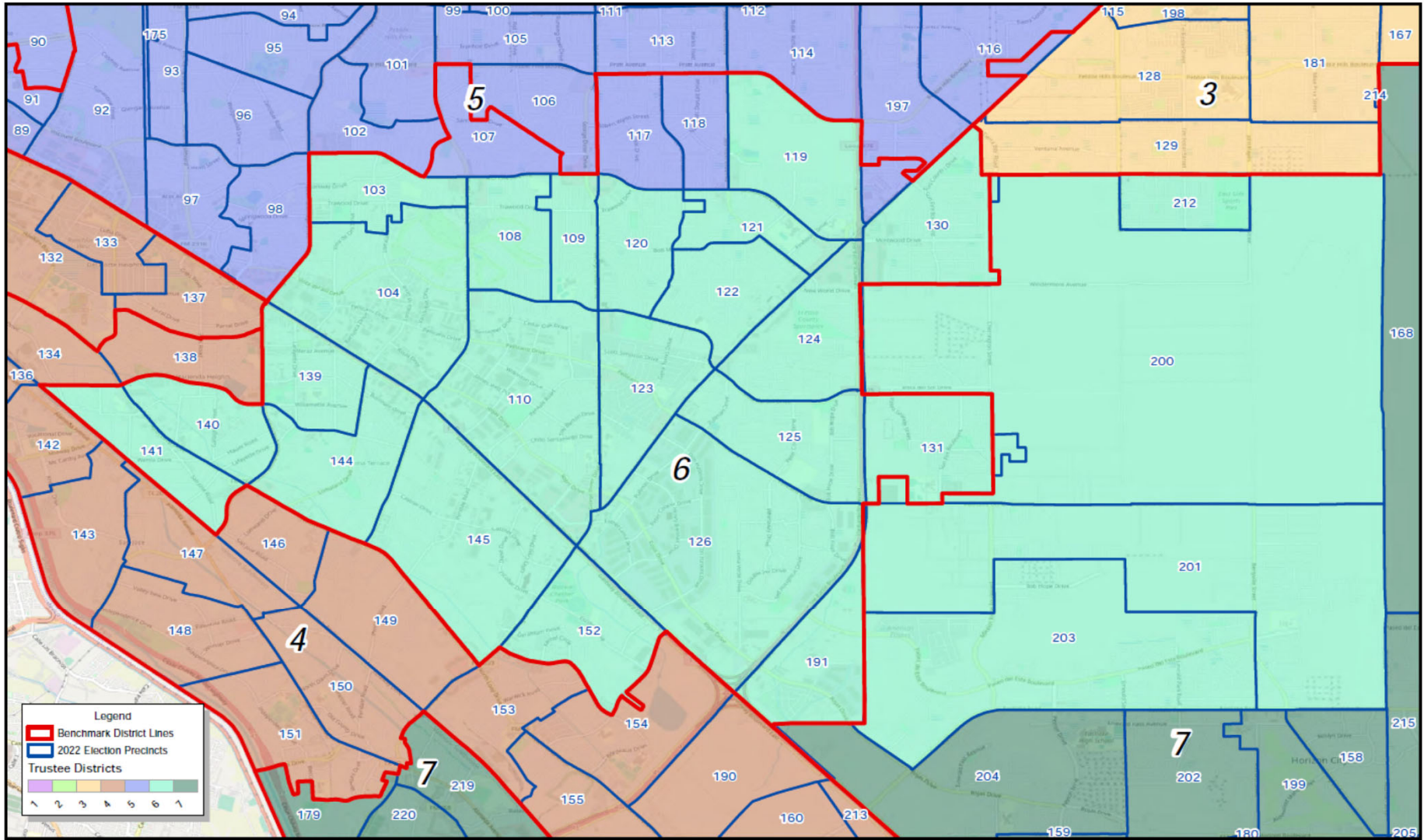




El Paso Community College Trustee District 4 - Illustrative Plan 1

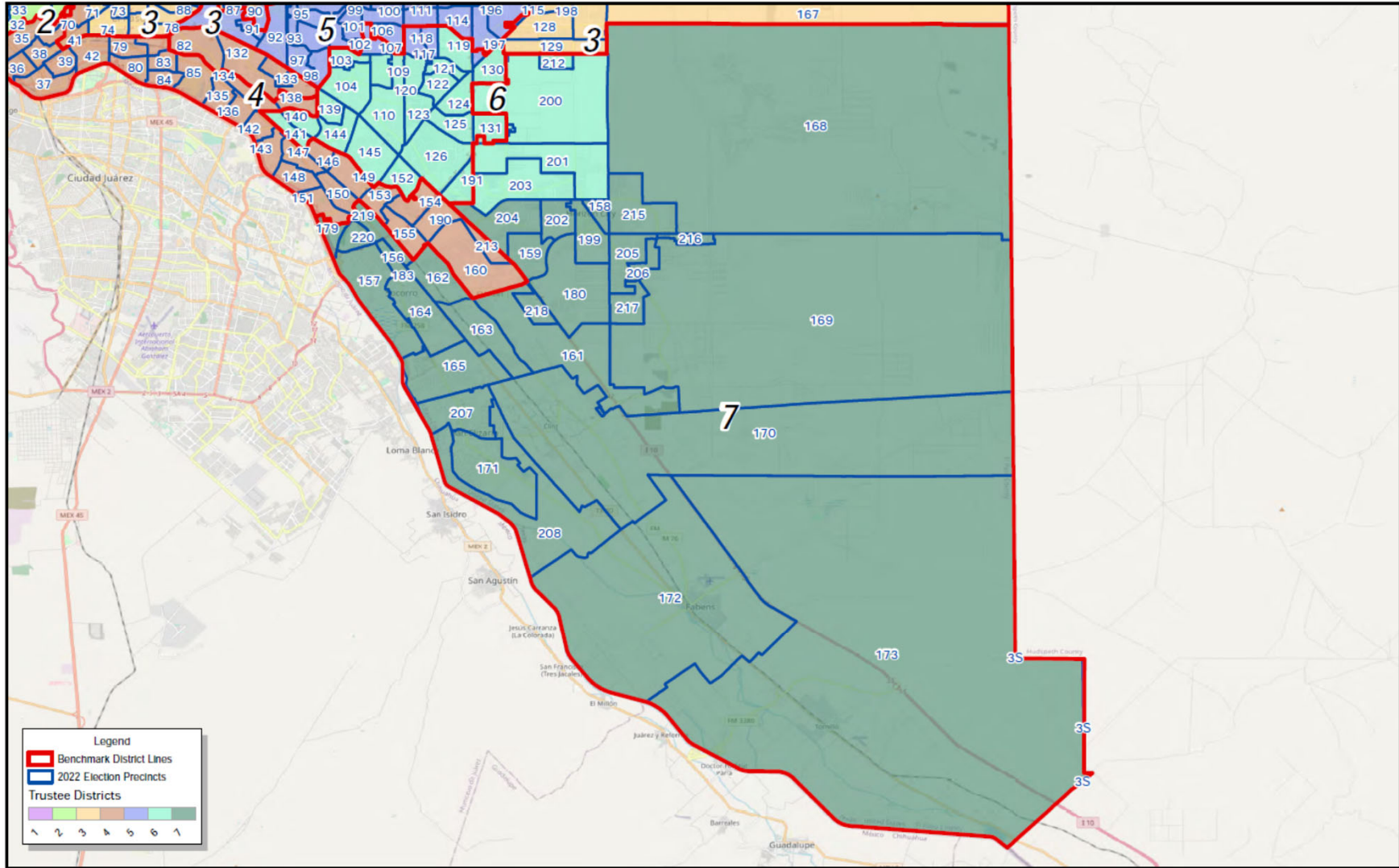




El Paso Community College Trustee District 6 - Illustrative Plan 1
