JOB SUMMARY: Responsible for general carpentry work including building cabinets, desks, and other furniture for the district. Assist the Senior Carpenter in specialized functions.

In-person work on campus is an essential function of this position.

ESSENTIAL FUNCTIONS:	YEARLY PERCENT OF TIME
1. Builds and installs cabinets, countertops, workstation partitions, floors, and other trim work.	45%
2. Repairs wood cabinets, countertops, workstations, doors, and equipment within the district.	25%
3. Constructs and repairs structural woodwork and equipment from blueprints and oral instructions.	10%
4. Purchases materials for assigned projects.	10%
5. Operates and maintains appropriate machinery and equipment.	5%
6. Perform other duties as assigned or directed by supervisor.	5%

PHYSICAL REQUIREMENTS:
