FB-12 Application and Approval for Academic Fresh Start

OBJECTIVE: To allow eligible students to take advantage of the opportunity for an Academic Fresh Start.

## I. GENERAL

To be eligible for an Academic Fresh Start, the student must have met the following conditions:

- 1. The student must be re-admitted to El Paso Community College (EPCC) and be classified as a Texas Resident for Tuition Purposes at the time the Academic Fresh Start is granted.
- 2. The student must submit an application for the Academic Fresh Start by the appropriate deadline and prior to rematriculating at EPCC. The application can be found on the Admissions & Aid website.
- 3. The student must submit official transcript(s) from any prior college/university attended.

## II. PROCESS

- A. Students wishing to take advantage of an Academic Fresh Start will complete the attached *Academic Fresh Start Application* and submit it to the Office of Admissions and Registration for review. The application will need to be submitted by the appropriate deadline, listed in the application, as determined by their new entry term.
  - 1. Upon receipt of the Academic Fresh Start Application, the Executive Director of Admissions and Registrar will review the student's academic record to ensure that the student is a Texas Resident for Tuition Purposes and that they are otherwise eligible for an Academic Fresh Start. Academic Fresh Start Applications will be denied if the applicant has already enrolled in classes at the College in an upcoming semester.
  - 2. The Executive Director of Admissions and Registrar will inform the applicant of the decision on their application for an Academic Fresh Start in writing. In cases where the application was denied, the decision letter will also include the reasons why the request could not be approved.
  - 3. If the application for an Academic Fresh Start is approved, the Executive Director of Admissions and Registrar will recalculate the student's Grade Point Average to exclude their prior grades at the College taken ten or more years prior to the semester in which they are planning to rematriculate. However, these grades will remain on the student's academic record and will appear on the student's official transcripts.
  - 4. If an Academic Fresh Start is approved the student will agree and understand that the Academic Fresh Start is irrevocable, is only applicable to EPCC, and will have no bearing on the student's financial aid standing and eligibility.
