#### What is Verification?

Verification is a standard process where the Financial Aid Office compares the information you submitted on your FAFSA with official financial documents. This helps ensure that you receive the correct amount of financial aid.

### **Definitions and Who to Include as Part of Your Household Information**

	• Dependent Children (receiving more than half of their support from student or spouse.)			
Other Household	Include only if:			
Members:	• They lived and received more than half of their financial support from students or contributors, and support will continue through June 30, 2026.

	• Children for whom student, spouse, or contributor are paying child support.			
	Children, you do not have legal custody given by the court.
