

## **CRRSA Act Higher Education Emergency Relief Fund**

## **Quarterly Fund Report - July 10, 2021**

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

El Paso Community College (EPCC) signed a Certification and Agreement with the U.S. Department of Education to receive additional funds appropriated under Section 18004(a) (1) of the CARES Act Section 314(a)(1) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA).

2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students.

EPCC received \$8,295,073.00 from the U.S. Department of Students for Emergency Financial Aid Grants to students.

3. The total amount of Emergency Financial Aid Grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of submission (i.e., as of the 30-day Report and every 45 days thereafter).

As of July 7, 2021, \$1,438,932.00 of emergency aid grant funds have been distributed to eligible students.

4. The estimated total number of students at the institution who are or could be eligible to participate in the Federal student financial aid programs under Section 484 of the Higher Education Act of 1965, as amended, and thus are eligible to receive Emergency Financial Aid Grants to students under Section 18004(a)(1) of the CARES Act.

Based on regulatory guidance released January 14, 2021 by the Department of Education the following are the students who could be eligible to receive Emergency Financial Aid Grants at EPCC.

As of July 7, 2021, 2,883 students have received a CRRSAA Emergency Financial Aid Grant.

Students were asked to complete an online application. Eligible students may received up to \$500.00 for the Summer 2021 semester.

EPCC has provided a variety of outreach to both support students and notify them of the availability of Emergency Financial Aid Grants from the CRRSA Act. Students enrolled for the summer semester were emailed directly by EPCC and it was promoted on the college's social media channels. Students were instructed to visit the College's <u>CRRSA Act</u> webpage to obtain more information about eligibility.
