Applicants must satisfy all Specialized Admissions criteria to include, General requirements, ATI TEAS minimum composite scores, Mandatory courses and Pre-Program specifics to qualify for ranking. Once a completed applicant, ranking points are derived from the most recent ATI TEAS composite score and the most recent G.P.A. of Ranking courses.

GENERAL REQUIREMENTS

Applicants must satisfy all criteria in order to be eligible for ranking consideration. The following is required:

- Acceptance by EPCC as an academic credit student
- **Advising session with a program designated Nursing Counselor should occur no later than six (6) months prior to ranking.**
- Successful completion of **ATI TEAS -The Test of Essential Academic Skills**
- **Two mandatory orientations are required for the Nursing program**
 1. Complete an **on-line Health Careers Orientation- Web link:** www.epcc.edu/Admissions/Orientation/health-careers-orientation to declare Nursing and/or Vocational Nursing as a secondary major
 - Pay application fee at cashier's window and **submit** the Health Careers Specialized Admissions Application to the Specialized Admissions Office for processing. Submit application via email to: specialized.adm@epcc.edu or hand carry to:

 2. Complete a **Nursing Specialized Admissions Orientation online. Web link:**

- Completion with a **"C" or better** of all academic and specialized courses listed on the degree plan
- **Minimum cumulative EPCC GPA of 2.5 is required**
- Submit all previous college/university transcripts (transliteration of all foreign coursework required) **prior to ranking**
- **Must have a High School Diploma or GED. Request official transcripts be sent to:**

ASSESSMENT SCORES

ATI-TEAS ASSESSMENT

The ATI TEAS exam must be taken for qualification and ranking into the VN program.

- Minimum Composite score-**62%**
- Official composite scores must contain all four (4)-subject areas (English & Language Usage, Math, Reading, and Science).
- If you are ranking June 2024 for Fall 2024 entry or ranking October 2024 for Spring 2025 entry you will take the ATI TEAS assessment

PREPARATION TOOLS:

- You can purchase an ATI TEAS Study Guide at: www.atitesting.com
- Check with your Nursing counselor for tutorial support services, i.e. tutoring, virtual, face to face, TEAS Boot Camp, etc.

- **If the ATI TEAS exam is taken outside of EPCC, contact ATI to request official scores be sent to EPCC TESTING Center. Follow up with the EPCC TESTING Center and provide them your student ID so your scores may be uploaded.**
- Additional costs will be charged by ATI to send official scores.
- Student is responsible to assure official ATI scores are received by EPCC.
- If you select to take the TEAS exam on -line , proctored through ATI, you need to contact the EPCC Toasting Center to request that your scores be uploaded.

ATI TEAS TEST & VALIDITY

- A minimum of **62% composite score** is required on the ATI TEAS assessment.
- Official scores are **valid for two years**
- **ONLY the MOST RECENT COMPOSITE SCORES** will be used for qualification and ranking.
- There is a **21-day** waiting period for re-testing with a **maximum of (4)** four attempts. **Re-testing prior** to the 21-day period will **invalidate** your ATI TEAS scores for EPCC Nursing qualification and ranking.

MANDATORY COURSES

Mandatory courses are those courses that a student must have successfully completed prior to ranking. Applicants who do not satisfactorily complete mandatory course work will not qualify eligibility to be ranked for a program.

NOTE: BIOL 1306 and BIOL 1106 are pre-requisites for BIOL 2401 and BIOL 2402. Prerequisite can be met through CLEP- (College Level Examination Program) or course completion.

- **BIOL 2401** Anatomy & Physiology I
- **BIOL 2402** Anatomy & Physiology II
- **RNSG 1301** Pharmacology
- **MATH 1324** Mathematics for Business & Social Sciences or **MATH 1314** College Algebra or **MATH 1342** Elementary Statistical Methods or higher-level MATH

- For qualification, BIOL 2401, BIOL 2402, and RNSG 1301 has a 10-year limit. Mandatory courses cannot be substituted with the exception of Math.
- All mandatory courses must be successfully completed with a minimum grade of "C" or better to qualify for ranking.

If you are receiving Financial Aid or VA assistance , please check with the FA or VA Office for funding eligibility of courses.

RANKING COURSES

Ranking courses cannot be substituted. The ranking GPA is calculated based on the following courses:

- **BIOL 2401** Anatomy & Physiology I
- **BIOL 2402** Anatomy & Physiology II
- **RNSG 1301** Pharmacology

You may repeat a course, however only the **MOST RECENT** grades will be considered for ranking.

DEADLINE FOR COMPLETING SPECIALIZED ADMISSIONS REQUIREMENTS

DOCUMENTS and APPLICANT RESPONSIBILITY- All Pre- Program Specialized Admissions documentation is due ONE MONTH prior to ranking date. Processing can take place in a few days or weeks depending on document type and individual circumstances. If documents have been received, but not processed, a student will be **coded as ineligible** for that placement because sufficient time was not given for validating and processing the information.

It is ultimately the APPLICANT'S **RESPONSIBILITY** to submit all required documentation to allow for normal processing and **VERIFY** that all documents are coded in our banner system. Pre-Program Specialized Admissions clearance is issued by submitting all Pre-Program Specialized Admissions documentation to **COMPLIO** : <https://americandatabank.com/coronavirus-passport-program/complio-login-screen>

PRE-PROGRAM SPECIALIZED ADMISSIONS REQUIREMENTS

1. All applicants for specialized programs must meet all Pre-program Specialized Admissions requirements **PRIOR to qualifying for ranking.**
2. **COMPLETION OF TWO ON-LINE ORIENTATIONS.**

- **Health Careers Orientation-Online**-Required to declare your intent to pursue EPCC Nursing programs- -RN and/or VN
 - Submit the Health Careers Orientation application to the Specialized Admissions Office for processing: specialized.adm@epcc.edu
- **Nursing Specialized Admissions Orientation-Online**
 - Submit Certificate of Completion to: <https://americandatabank.com/coronavirus-passport-program/complio-login-screen/>

- **CURRENT CPR CERTIFICATE**- American Heart Association Healthcare Provider- (accepted on-line with skills training or face to face)
- **FIRST AID CERTIFICATION** – National Safety Council Course or American Academy of Orthopedic Surgeon-(accepted on-line with skills training or face to face)
- **IMMUNIZATIONS and TITERS** – Immunizations and Blood titers must be completed prior to placement. Immunizations **MUST be started now if you are selecting Nursing**. Immunizations include: **Hepatitis B series, MMR, Tdap, Varicella, Influenza, Meningitis**, or as directed by DHS.
 - **POSITIVE TITER** required for Hepatitis B; if negative, repeat immunization series or Twinrix series or Heplisav-b immunization and repeat titer (ask your healthcare provider for information)
 - **POSITIVE TITER** required for Measles
 - **POSITIVE TITER** required for Mumps
 - **POSTIVE TITIER** required for Rubella, (MMR) (if any Negative, series must be repeated)
 - **POSITIVE TITER** required for Varicella (if Negative, series must be repeated)

NOTE: After a vaccination is administered, you must wait 4-6 weeks for immunity to show up on the TITER

- **Tetanus/Diphtheria and Pertussis (Tdap)** or as directed by DSHS-(Expires after 10 years)
- **Influenza** is required **for October placement but not for June placement**; renew every year
- **Meningitis** may be required by college, check with Registrar's office- (Good for 5 years)- (Monitored by the Admissions Office)
- **See Nursing Lab Supervisor or Nursing Counselor for complete information**
- **PHYSICAL EXAM** completed by a Physician, Nurse Practitioner or Physician's Assistant licensed in the USA-valid for 6 months for ranking qualification.
- **PHYSICAL TECHNICAL STANDARD form (completed)** –form obtained through Nursing Website
- **Two COVID 19 vaccination series or one booster** is required by all hospitals. Medical or religious exemption is allowed but proof of either is expected.
- **NURSING DISCLOSURE FORM** -form obtained through Nursing website

A tracking system, American Databank COMPLIO, will assist students and coordinators to be compliant with immunizations, CPR, First Aid, physical, etc. implementation is pending for the Nursing program. Students will be expected to pay all fees that are associated with the America Databank COMPLIO tracking system.

Background Check and Substance Abuse Screening are **Post Specialized Admissions** requirements, see page 4 for additional information.

ADDITIONAL INFORMATION

- **Official Ranking Dates:**
 - June 3, 2024 for Fall 2024 entry
 - **(Clinical clearance documentation due One Month prior to ranking date)**
 - October 1, 2024 for Spring 2025 entry
 - **(Clinical clearance documentation due One Month prior to ranking date)**
- **Program Begins** – Fall and Spring
- **Program Hours** – 51 credit hours
- **Maximum Students Admitted:** 25 students in Fall and Spring (unless otherwise noted)
- Students must have successfully completed all required courses on the degree plan in order to graduate with a Vocational Nursing Certificate of Completion
- The Texas Board of Nursing allows a student three years to complete the Vocational Nurse Certificate of Completion after official enrollment in the first Vocational Nursing course.
- Students will be expected to pay the fees that are associated with ATI standardized testing.

POST-SPECIALIZED ADMISSIONS REQUIREMENTS

Students are responsible for the following requirements **AFTER you are accepted into the program**. Everything must be current through the **entire academic semester or summer you want to register**. Documents should be submitted to **COMPLIO** at: <https://americandatabank.com/coronavirus-passport-program/complio-login-screen/>

- **PROGRAM ORIENTATION**-one day-(Mandatory)
- **COMMUNITY WIDE ORIENTATION**-<https://www.epcc.edu/Admissions/Orientation/community-wide-orientation> (Renew every year)
- **HIPAA TRAINING** - <https://www.epcc.edu/Academics/Health/hipaa> (Renew every year)
- Uniforms, Specialized Equipment, Lab Supplies and Liability Insurance required for clinicals.
- **TUBERCULOSIS** –Two PPD’s to be completed after ranking. After initial immunization, second one must be completed within 7-21 days later. If before 7 days or after 21 days, must start series again. Timing is critical. After initial double PPD, it is to be done annually) or Chest x-ray (as needed) (or as requested by clinical facilities) or Quantiferon Blood Test or Tspot
- **TWO BACKGROUND CHECKS** will be completed by each student. **1st** – Upon qualification and placement into the program the student is required to complete an annual background check through the American Data Bank <http://www.elpasoex.com/> A positive background check from the Texas Board of Nursing , (BON) may prevent students from entering/staying in the program. The student will not be able to go to the clinical areas or health care facilities until cleared. (Background check questions can be directed to the Dean of Nursing at 915-831-4220). **Students who fail to obtain clearance may be prohibited from admission or enrollment in specified program/courses.**
- **SUBSTANCE ABUSE SCREENING**–<http://www.elpasoex.com/> - American Data Bank - Students who cannot participate in clinical rotations due to adverse activities revealed through substance abuse testing cannot complete course or program requirements. **Students who fail to obtain clearance may be prohibited from admission or enrollment in specified programs/courses.**
- **PROVIDE PROOF OF PERSONAL MEDICAL INSURANCE TO MEET AFFILIATE REQUIREMENTS.**

2nd Background check. Upon accepting a seat into the program, your name is submitted to the Texas Board of Nursing (BON). The BON will email the student the Texas Fingerprint Service Code Form which enables the student to make an appointment with IdentoGO to get their fingerprinting completed. Fingerprinting with a background check from FBI is required by the BON for licensure requirements and must be completed prior to the end of the first semester of the program.

VOCATIONAL NURSING (CLINICAL) COURSES

PRE-PROGRAM SPECIALIZED ADMISSIONS REQUIREMENTS- (Documents needed to qualify for ranking)

- **Current CPR Certificate-(BLS)-** American Heart Association Healthcare Provider
- **First Aid Certification** – National Safety Council Course or American Academy of Orthopedic Surgeon
- **Positive Titers – Immunizations and Blood titers must be completed prior to placement. Immunizations include: Hepatitis B series, Tuberculin Test, MMR, Tdap, Varicella, Influenza, Meningitis, or as directed by DSHS**
- **Immunization and Blood Titer Requirements for Health students flow chart located on Nursing website.**
- **Immunizations**
 - **Tetanus/Diphtheria and Pertussis (Tdap)** or as directed by DSHS
 - **Influenza** is required for **October placement but not for June placement**
 - **Meningitis** may be required by college if under 22 years of age; check with registrar's office-not monitored by Nursing
- **Physical Exam** completed by a Physician, Nurse Practitioner or Physician's Assistant licensed in the USA
- **Physical Technical Standard form (completed)** -(valid for 6 months)**complete with Physical exam**
- **Two COVID 19 vaccination series or one booster** is required by all hospitals. Medical or religious exemption is allowed but proof of either is expected.
